## CREDIT APPLICATION Terms and Conditions

1. You must:
  - a. Notify us immediately if any detail or information appearing on this form changes.
  - b. Pay all amounts due to us in the manner and at the address specified for payment on or by 21 days following the date of our invoice.
  - c. Pay interest at the rate of 15% per annum calculated on any unpaid amount from the due date for payment to the date the amount is paid in full.
  - d. Notify us if you dispute any amount within 10 working days of the date of our invoice.
2. We may cancel your credit facility with us if you fail to comply with these terms and conditions.
3. You authorise us to use information about you at any time held by us for all purposes of and incidental to establishing and maintaining a credit facility with us. This includes credit assessment, debt assessment and debt collecting, credit reporting, account administration and enforcement of these terms and conditions.
